## DISCOVERY PASS

### New Deer Valley ticket options

The Discovery Pass is offered to fractional and timeshare owners who pay property taxes to the state of Utah.

To qualify for the Discovery Pass, you MUST present documentation showing payment of current Utah property taxes and a photo ID before the Pass will be issued. Spouse and/or dependent children of the owner can qualify for the program. We do not accept letters from property management companies as proof of property tax payment.

Two qualifying participants may share one Ten Pass; same age categories as listed below apply. Five Passes may not be shared. **Participants must make initial purchase by November 30, 2012.**

Adult 10 Pass	\$730 (\$73/day)
Adult 5 Pass	\$375 (\$75/day)
Teen (13-17) 10 Pass	\$640 (\$64/day)
Teen (13-17) 5 Pass	\$340 (\$68/day)
Child (12 and under) 10 Pass	\$430 (\$43/day)
Child (12 and under) 5 Pass	\$235 (\$47/day)

During the December holiday period (12/26/12 - 1/1/13) and the Presidents' Day weekend (2/16 - 18/2013), this discount does not apply and an upgrade to the holiday ticket rate will be required.

#### Guidelines and Restrictions:

- You may only purchase and use one Pass at a time. Two qualifying participants may share one Ten Pass; same age categories as listed above apply. Co-owner, if applicable, must be named at the time of purchase
- Pass type is determined by holder's age on December 8, 2012
- 2012/2013 Discovery Passes are redeemable for lift tickets only during the 2012/2013 ski season
- Once all passes are used, you may renew at the same rate through the 2012/2013 ski season
- One Pass per person may be redeemed for a daily lift ticket. If shared, each Pass holder must be present in order to receive a lift ticket
- It is illegal to sell tickets. You may be subject to prosecution for theft of services for violation of this policy. Lost passes and/or tickets will not be refunded or replaced
- Valid homeowner's statement listing taxes as paid is required before Pass will be issued
- Pass does not guarantee a lift ticket if Deer Valley reaches capacity
- Deer Valley is scheduled to open for skiing December 8, 2012, and close April 14, 2013, conditions permitting
- Daily lift tickets purchased prior, or subsequent to the purchase of a Discovery Pass will not be refunded or credited
- The terms and conditions of the Liability Statement as stated on the Deer Valley lift tickets are binding each time the facilities are used at Deer Valley Resort
- No snowboards, please
